

Explanation: This Ordinance amends section 2-20.4 entitled, “Fund Raising: Service Charges and Commercial Use Charges” by (i) renaming Section 2-20.4, “Fund Raising; Service Charges and Fees for Use of Recreational Facilities” and (ii) repealing and replacing 2-20.4 (b) in its entirety.

**TOWNSHIP OF WARREN  
ORDINANCE NO. 10-04**

**BE IT ORDAINED**, by the Township Committee of the Township of Warren, County of Somerset, State of New Jersey as follows:

**SECTION I.** Section 2-20.4 entitled, “Fund Raising; Service Charges and Commercial Use Charges is hereby amended by (i) renaming Section 2-20.4, “Fund Raising; Service Charges and Fees for Use of Recreational Facilities” and (ii) repealing and replacing 2-20.4 (b) in its entirety. The entry shall read as follows:

*Fund Raising; Service Charges and [Commercial Use Charges] Fees for Use of Recreational Facilities*

[*b. Commercial Use of Recreational Fields and Pavilion Charges . Commercial, for profit use, of each township recreation field shall require payment, after approval of the use by the township administrator, as follows: one-half day (three hours) fifty (\$50.00) dollars per field and full day (six hours) one hundred (\$100.00) dollars per field. Commercial, for profit use, of the Township Pavilion shall require payment, after approval of the use by the township administrator, as follows: one-half day (three hours) fifty (\$50.00) dollars and full day (six hours) one hundred (\$100.00) dollars.*]

*b. Fees for Use of Recreational Facilities. All applicants seeking the use of the Township of Warren’s Pavilion and Athletic Fields (grass and synthetic turf) must complete a Department of Recreation facility use application and pay the fee prescribed by the following table:*

Non-Residents & Out-of-Town for Profit entities	\$100hr
<b>Field Usage Fees</b>	
Township Residents & Township Nonprofit entities	Free seasonal play ONLY
Tournament//Special Event Fees (grass or synthetic)	Range: Under 100 participants-\$50(3hr)  100-200 participants-\$50(1hr)  over 200 participants-\$100(1hr)

<b>(Grass fields)</b>	
Nonprofit entities under 66% Residents & In-Town for Profit entities <sup>(**)</sup>	\$50(3hr)
Non-Residents & Out-of-Town for Profit entities	\$50 (1hr)
<b>(Synthetic Turf Fields)</b>	
Nonprofit entities under 66% Residents & In-Town for Profit entities <sup>*(**)</sup>	\$100(3hrs)
Non-Residents & Out-of-Town for Profit entities	\$200 (1 hr)
<b>Refund Processing Fee</b>	<b>\$20 per transaction</b>

\* A Township Nonprofit entity is one in which at least 66 % of the organization is comprised of Warren Township residents.

(\*\*) The Township Committee has the right to adjust usage fees if the non-profit can prove the percentage of sending district fields and users are comparable to the percentage of Warren Township fields and users. Sending district to Watchung Hills Regional High School towns include: Long Hill, Watchung Borough and Green Brook.

**NOTE: ANY NONPROFIT ORGANIZATION OBTAINING USE OF A TOWNSHIP RECREATIONAL FACILITY IS STRICTLY PROHIBITED FROM SUBLETTING ITS USE TO ANOTHER ENTITY.**

**SECTION II.** This Ordinance shall take effect immediately upon final passage and publication according to law.
