WHEREAS, said Director may also approve the insertion of any item of appropriation for equal amount; and

WHEREAS, the Township of Warren has received funding pursuant to check number 0013420402 dated November 8, 2018, from the General State Fund in the sum of \$3,310.07; and

NOW, THEREFORE BE IT RESOLVED that the Township of Warren, in the County of Somerset, hereby requests the Director of the Division of Local Government Services approve the insertion of an item of revenue in the budget of the year 2018 in the sum of \$3,310.07 pursuant to a grant received from the State of NJ Drunk Driving Enforcement Fund; and


BE IT FURTHER RESOLVED that a like sum of \$3,310.07 be appropriated under the title "2018 Drunk Driving Enforcement Fund".


