

**TOWNSHIP OF WARREN
RESOLUTION NO. 2018-53
AWARD OF CONTRACT TO FIELD TURF
FOR EAST COUNTY RESERVE ATHLETIC FIELD THROUGH
ESCNJ UTILIZING THE COOPERATIVE PRICING SYSTEM**

WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, the Educational Services Commission of New Jersey, ("ESCNJ"), has offered voluntary participation to municipalities in Cooperative Pricing System for the purchase of goods and services; and

WHEREAS, ESCNJ, awarded a contract for Synthetic Turf Field Installation services to Field Turf, 175 N. Industrial Blvd. NE, Calhoun, GA 30701; and

WHEREAS, Warren Township requires this service and the Township Administrator has recommended that the contract be awarded to Field Turf; and

WHEREAS, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and made a part hereof indicating that the maximum for the within expenditure is charged to the following account #'s 8-03-286-56-2401; \$26,854.57 and X-02-40-764-901; \$375,000.00; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Warren, that the purchasing agent is hereby authorized to utilize Field Turf for the synthetic turf field installation at East County Reserve Athletic Field pursuant to ESCNJ – Contract #016-G; and


BE IT FURTHER RESOLVED, that this contract shall not exceed \$401,854.57.
