

**TOWNSHIP OF WARREN

RATIFYING AND CONFIRMING EXTENSION OF OUTDOOR DINING,  
LIMITED SALES AND EXERCISE CLASSES WITHIN CERTAIN  
MUNICIPAL PARKS AND AREAS ADJACENT TO THE FITNESS OR  
WELLNESS BUSINESS DURING THE COVID-19 PANDEMIC THROUGH  
DECEMBER 31, 2020**

**WHEREAS**, Section 12 entitled Effective Date” of Ordinance No. 20-19 entitled “An Ordinance Permitting Outdoor Dining, Limited Sales and Exercise Classes within Certain Municipal Parks and Areas Adjacent to the Fitness or Wellness Business During the COVID-19 Pandemic” was set to expire on November 1, 2020; and

**WHEREAS**, inasmuch as the Governor’s Executive Order declaring a State of Emergency remains in effect and will continue to remain in effect for the foreseeable future; and

**WHEREAS**, as a result of the foregoing, Ordinance No. 20-19 was extended by voice vote taken at its regularly scheduled meeting held on October 15, 2020 through December 31, 2020; and

**WHEREAS**, the Township Committee, at its meeting of October 15, 2020 clarified certain issues in Ordinance No. 20-19 such that space heaters and shielded and subdued lighting be allowed since we are entering into shorter and colder days and evenings; and

**WHEREAS**, the regulation of space heaters and lighting are covered by Municipal Fire and or other codes and are already addressed in Ordinance No. 20-19; and

**WHEREAS**, as of December 1, 2020, outdoor tents will be permitted pursuant to the New Jersey Uniform Construction Code.

**NOW THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey that it does hereby ratify and confirm the action taken by it at its regular meeting of October 15, 2020, extending the continued effectiveness of Ordinance No. 20-19 through December 31, 2020; and

**BE IT FURTHER RESOLVED**, that Ordinance No. 20-19 may be further extended beyond December 31, 2020 by Resolution of the Township Committee.
