

**TOWNSHIP OF WARREN
RESOLUTION NO. 2018-137
AWARD OF CONTRACT FOR 2018 STREETS OVERLAY TO
P & A CONSTRUCTION, INC.**

WHEREAS, bids for overlay & milling of various township roads were advertised in the May 24, 2018, edition of the Courier News, and received on June 7, 2018 at 11:00 a.m.; and

WHEREAS, the following seven (7) bids were received for the proposed work based on a maximum tonnage of 12,000:

WHEREAS, it is the recommendation of the Superintendent of Public Works that the bid be awarded to P & A Construction, Inc., P.O. Box 28, Colonia, NJ 07067 in the maximum amount not to exceed \$855,000.00; and

WHEREAS, the Township Attorney has reviewed the bid documentation and finds all bids to be responsive and responsible; and

WHEREAS, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and made a part hereof indicating that the following appropriations for the within expenditure is charged to the following account numbers \$635,000 to 8-01-26-290-6597; \$100,000.00 to 8-01-44-911-6902; \$120,000.00 to 7-01-26-290-6597;

BE IT FURTHER RESOLVED, that the Superintendent of Public Works shall provide a report as to the roads completed by September 15, 2018.


BE IT FURTHER RESOLVED, that the appropriate Township officials are authorized to execute the necessary contracts and purchase orders.
