

**TOWNSHIP OF WARREN
RESOLUTION NO. 2018-165
AWARD OF PROFESSIONAL SERVICES CONTRACT
SALUSTRO ARCHITECTURAL ASSOCIATES, LLC**

WHEREAS, the Township of Warren ("Township") has a need for a Professional Architect and Engineer in order to prepare construction documents for the construction of a television studio for the Township's cable television station in the new municipal building, Warren New Jersey; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., specifically N.J.S.A. 40A:11-5, permits the award of professional services without public advertisement as defined in N.J.S.A. 19:44A-20.7 or competitive bidding, pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Township received a proposal from Salustro Partnership Architects, LLC to provide professional architectural and engineering services on behalf of the Township; and

WHEREAS, the Township Committee believes that it is in the best interests of the Township to enter into a Contract for Professional Services ("Contract") with Salustro Architectural Associates, LLC to provide professional architectural and engineering services in accordance with the terms of that Contract.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey as follows:

1. The Mayor and Township Clerk are hereby authorized to enter into a Professional Services Contract, a copy of which is annexed hereto, with Salustro Architects Partnership, LLC to prepare construction documents for the construction of a television studio for the Township's cable television station in the new municipal building for a lump sum amount of Nineteen Thousand Three Hundred (\$19,300.00) Dollars.

2. This Contract is awarded without competitive bidding as a "professional service" under the Local Public Contracts Law, more specifically, N.J.S.A. 40A:11-5, which permits such work to be performed without advertising for bids.

3. The Business Disclosure Entity Certification shall be placed on file with this Resolution.

4. The Chief Financial Officer certifies that funds to pay for this Professional Services Contract at a maximum dollar amount of Nineteen Thousand Three Hundred (\$19,300.00) Dollars are available in Account No. X-04-55-853-6001. A Certification of Available Funds shall be provided by the Chief Financial Officer and is attached hereto and made a part hereof.

5. A notice of this action shall be printed in the official newspapers required by law within ten (10) days of the adoption of this Resolution


