**EXTENSION OF CONTRACT – INLINE AIR CONDITIONING CO. INC. FOR
HVAC SERVICES THROUGH ESCNJ UTILIZING THE COOPERATIVE
PRICING SYSTEM**

WHEREAS, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

WHEREAS, the Educational Services Commission of New Jersey, (“ESCNJ”), has offered voluntary participation to municipalities in Cooperative Pricing System for the purchase of goods and services; and

WHEREAS, ESCNJ, awarded a contract for HVAC services to In-line Air Conditioning Co. Inc., 82 East 21st Street, Bayonne, NJ 07002, MRESC Bid # 15/16-58 expiring March 17, 2018; and

WHEREAS, Warren Township requires this service and hereby extends the contract until November 1, 2019; and

WHEREAS the Superintendent of Public Works has recommended that the contract be awarded to In-line Air Conditioning Co. Inc.; and

WHEREAS, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and is made a part hereof indicating that the appropriation for the within expenditure is charged to account # 8-01-26-310-6501 under Maintenance and Material in the amount of \$10,000 and #8-01-26-310-6102 under Contract Services in the amount of \$15,000;

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Warren, that the purchasing agent is hereby authorized to utilize In-line Air Conditioning Co. Inc. for HVAC services pursuant to MRESC Bid # 15/16-58; and

BE IT FURTHER RESOLVED, that this contract shall not exceed \$25,000.

BE IT FURTHER RESOLVED, that the appropriate Township officials are authorized to execute the necessary contracts and purchase orders.
