WHEREAS, Magic Touch Construction Co., Inc., 59 West Front Street, Keyport, NJ 07735 was awarded the bid from July 1, 2016 through June 30, 2018, with extensions as permitted by law; and

WHEREAS, Warren Township requires this service and hereby extends the contract until June 30, 2019; and

WHEREAS, a certificate showing the availability of funds for this contract in accordance with N.J.A.C. 5:30-14.5 has been provided by the Chief Financial Officer and is made a part hereof indicating that the appropriation for the within expenditure is charged to account # 8-01-26-310-6501 said authorized contract will not exceed \$30,000.
