RESOLUTION NO. 2021-115**

**AWARD OF PROFESSIONAL SERVICE CONTRACT TO  
KENNON SURVEYING SERVICES, INC. FOR UPDATING TOWNSHIP TAX MAPS**

**WHEREAS**, there exists a need for the professional services of a Professional Land Surveyor to review, sign and update the Township’s tax maps; and

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-1 *et seq.*, specifically N.J.S.A. 40A:11-5, permits the award of professional services without public advertisement as defined in N.J.S.A. 19:44A-20.7 or competitive bidding, pursuant to the provisions of N.J.S.A. 19:44A-20.4; and;

**WHEREAS**, Kennon Surveying Services, Inc., has submitted a proposal dated June 20, 2014 attached hereto, indicating that they can provide the professional land surveying services requested by the Township of Warren; and

**WHEREAS**, the Township Council believes it to be in the best interest of the Township to enter into a Professional Services Contract with Kennon Surveying Services, Inc. to perform those services identified in their April 27, 2021 proposal attached hereto from the date of the Professional Services Contract through January 30, 2022.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Warren, County of Somerset, State of New Jersey, as follows:

1. The Mayor and Township Clerk are hereby authorized and directed to execute the attached Contract for Professional Services with Kennon Surveying Services, Inc. to provide those services identified in their April 27, 2021 proposal at a rate not to exceed \$1,450.00.
2. This Contract is awarded without competitive bidding as a “professional service” under the provisions of the Local Public Contracts Law, more specifically N.J.S.A. 40A:11-5, which permits such work to be performed without advertising for bids.
3. A Certificate showing the availability of funds for the Contract authorized hereby shall be provided by the Chief Financial Officer and is attached hereto and made a part hereof, indicating that the appropriation for the within expenditure is charged to Account No. 1-01-20-165-6102.
4. The Business Disclosure Entity Certification shall be placed on file with this Resolution.
5. A notice of this action shall be printed in the official newspapers required by law within ten (10) days of the adoption of this Resolution.
