

**TOWNSHIP OF WARREN  
RESOLUTION NO. 2021-099**

**AWARD OF CONTRACT FOR LAND SURVEYING SERVICES  
KENNON SURVEYING SERVICES, INC.**

**WHEREAS**, the Township of Warren (“Township”) has a need for a Professional Land Surveyor to provide land surveying services in connection with the minor subdivision of the Mt. Bethel Baptist Church Cemetery located at Lot 10.01, Block 37 (233 Mountain View Road); and

**WHEREAS**, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., specifically N.J.S.A. 40A:11-5, permits the award of professional services without public advertisement as defined in N.J.S.A. 19:44A-20.7 or competitive bidding, pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

**WHEREAS**, the Township received a proposal from Kennon Surveying Services, Inc. to provide professional land surveying services on behalf of the Township; and

**WHEREAS**, the Township Committee believes that it is in the best interests of the Township to enter into a Contract for Professional Services (“Contract”) with Kennon Surveying Services, Inc. to provide professional land surveying services in accordance with the terms of that Contract.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey as follows:

1. The Mayor and Township Clerk hereby authorize the execution of a Professional Services Contract, a copy of which is annexed hereto, with Kennon Surveying Services, Inc. to provide professional land surveying services for a lump sum amount of Six Thousand Five Hundred (\$6,500) Dollars.
2. This Contract is awarded without competitive bidding as a “professional service” under the Local Public Contracts Law, more specifically N.J.S.A. 40A:11-5, which permits such work to be performed without advertising for bids.
3. The Business Disclosure Entity Certification shall be placed on file with this Resolution.
4. The Chief Financial Officer certifies that funds to pay for this Professional Services Contract at a maximum dollar amount of Six Thousand Five Hundred (\$6,500) Dollars are available in Account No. 1-01-20-155-6111 A Certification of Available Funds shall be provided by the Chief Financial Officer and is attached hereto and made a part hereof.
5. A notice of this action shall be printed in the official newspapers required by law within ten (10) days of the adoption of this Resolution.
