**AWARD OF CONTRACT
SAW MILL ROAD IMPROVEMENT PROJECT**

WHEREAS, bids for the Saw Mill Road Improvement Project were advertised in the July 15, 2021 edition of the Courier News and received on August 10, 2021 at 11:00 a.m.; and

WHEREAS, twelve (12) bids were received, and it is the recommendation of the Township Administrator that the bid be awarded to JA Alexander, Inc., 130-158 John F. Kennedy Drive North, Bloomfield, New Jersey 07003 in the amount not to exceed \$227,379.26; and

WHEREAS, the bids submitted and their totals are as follows:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey that JA Alexander, Inc. be awarded the bid for the Saw Mill Road Improvement Project in the amount not to exceed \$227,379.26.

BE IT FURTHER RESOLVED that the appropriate Township officials are authorized to execute the necessary contracts and purchasing orders.

FURTHER RESOLVED that this award is subject to review and approval from NJDOT, as funding is from a State Grant.
