

**TOWNSHIP OF WARREN
RESOLUTION NO. 2021-230
AWARD OF CONTRACT – NORTHEAST COMMUNICATIONS, INC.
EMERGENCY COMMUNICATIONS EQUIPMENT POINT TO POINT MICROWAVE
PHASES 3, 4 and 5 FOR POLICE, FIRE and EMS RADIO SYSTEMS**

WHEREAS, on April 16, 2020 per Resolution No. 2020-086 a contract was awarded to Northeast Communications for Phase 1 of the purchase, installation and maintenance of Emergency Communications Equipment for the Warren Police and Fire Departments, not to exceed \$25,000; and

WHEREAS, on August 19, 2021 per Resolution No. 2021-204 a contract was awarded to Northeast Communications for Phase 2 of the purchase, installation and maintenance of Emergency Communications Equipment for the Warren Police and Fire Departments, not to exceed \$350,000; and

WHEREAS, the Township Administrator is requesting authorization to purchase the following pursuant to State Contract #83898 from Northeast Communications, Inc., 244 East Union Turnpike, Wharton, NJ 07885 for Emergency Communications Equipment in the amount not to exceed \$211,960.98 for Phases 3, 4 and 5, with a total contract amount not to exceed \$465,038.64; and

WHEREAS, a certificate showing the availability of funds for the contract authorized hereby shall be provided by the Chief Financial Officer and made a part hereof, indicating that the appropriation for the within expenditure is charged to the following accounts # x-04-55-882-6007.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Warren, that the contract is awarded to Northeast Communications for Phases 3, 4 and 5 for the connection of the communication system to microwave receivers for the Warren Police and Fire Departments and Rescue Squad; and

BE IT FURTHER RESOLVED, that the Qualified Purchasing Agent is authorized to execute the necessary purchase order.
