**HALECON, INC. – CHANGE ORDER #1
CONSTRUCTION OF BASKETBALL COURTS AND OTHER RELATED IMPROVEMENTS**

WHEREAS, bids for the Construction of Basketball Courts and Other Related Improvements were advertised in the July 6, 2022 edition of the Courier News and received on August 4, 2022; and

WHEREAS, on August 18, 2022 the Township Committee of the Township of Warren, by Resolution No. 2022-201, awarded a contract to Halecon, Inc., for the construction of basketball courts and other related improvements; and

WHEREAS, the Recreation Director and Township Administrator have recommended adjustments listed on file in the Warren Township Purchasing Office and request approval of this change order; and

WHEREAS, this change order is required to expand the footprint of the playground area from the size shown on the plans; and

WHEREAS, a certificate showing the availability of funds for this contract, in accordance with N.J.A.C. 5:30-14.5, shall be provided by the Chief Financial Officer and made a part thereof, indicating that the appropriation for the within expenditure is charged to the following account, 3-03-286-56-2401.
