

**TOWNSHIP OF WARREN
RESOLUTION NO. 2023-144**

**AWARD OF CONTRACT FOR LAND SURVEYING SERVICES
DPK CONSULTING LLC**

WHEREAS, the Township of Warren (“Township”) has a need for a Professional Land Surveyor to provide land surveying services from the former Chubb entrance to Round Top Road (+ or – 7,282 LF) as more fully described in a Proposal dated May 9, 2023, attached hereto (the “Survey Work”); and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., specifically N.J.S.A. 40A:11-5, permits the award of professional services without public advertisement as defined in N.J.S.A. 19:44A-20.7 or competitive bidding, pursuant to the provisions of N.J.S.A. 19:44A-20.4; and

WHEREAS, the Township received a proposal from DPK Consulting, LLC to provide professional Survey Work on behalf of the Township; and

WHEREAS, the Township Committee believes that it is in the best interests of the Township to enter into a Contract for Professional Services (“Contract”) with DPK Consulting, LLC to provide the professional Survey Work in accordance with the terms of that Contract.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey as follows:

1. The Mayor and Township Clerk hereby authorize the execution of a Professional Services Contract, a copy of which is annexed hereto, with DPK Consulting, LLC to provide the professional Survey Work for a fee not to exceed Twenty Thousand (\$20,000) Dollars.
2. This Contract is awarded without competitive bidding as a “professional service” under the Local Public Contracts Law, more specifically N.J.S.A. 40A:11-5, which permits such work to be performed without advertising for bids.
3. The Business Disclosure Entity Certification shall be placed on file with this Resolution.
4. The Chief Financial Officer certifies that funds to pay for this Professional Services Contract at a maximum dollar amount of Twenty Thousand (\$20,000) Dollars are available in Account No. X-04-55-927-6001 A Certification of Available Funds shall be provided by the Chief Financial Officer and is attached hereto and made a part hereof.
5. A notice of this action shall be printed in the official newspapers required by law within ten (10) days of the adoption of this Resolution.
