**AWARD OF CONTRACT – NATIONAL AUTO FLEET GROUP  
TWO (2) 2024 CHEVROLET SILVERADO 3500HD**

**WHEREAS**, the Township of Warren has the need for two (2) vehicles for use by the Township; and

**WHEREAS**, the Township of Warren is authorized, pursuant to N.J.S.A. 52:34-6.2 (b) (3) to use alternative procurement methods by entering into nationally recognized cooperative contracts; and

**WHEREAS**, the Township has compared pricing for comparable goods from other vendors and has determined that the use of a cooperative purchasing agreement shall result in cost savings to the Township; and

**WHEREAS**, the Warren Township Public Works Superintendent and the Township Administrator have recommended that the Township purchase two (2) 2024 Chevrolet Silverado 3500HD (CK30903) 4WD Reg Cab 142", 8.2" Box Work Trucks from National Fleet Auto Group, through a national cooperative purchasing agreement with Sourcewell, subject to certain terms and conditions.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Warren, County of Somerset and State of New Jersey as follows:

1. The Township Committee shall purchase from National Auto Fleet Group two (2) 2024 Chevrolet Silverado 3500HD (CK30903) 4WD Reg Cab 142" Work Truck 8.2" Box in the total amount of \$98,212.58 (\$49,106.29 per vehicle).
2. The purchase is made pursuant to a national cooperative purchasing agreement with Sourcewell, Contract Number 091521-NAF.
3. A Notice of Intent to award this Contract was advertised in the Courier News, an official newspaper of the Township, on August 31, 2023.
4. A Certificate showing the availability of funds for the Contract authorized hereby is provided by the Chief Financial Officer and is made a part hereof, indicating that the appropriation for the within expenditure is charged to the following account numbers:
