**APPROVING AND AUTHORIZING THE EXECUTION OF THE AMENDED AND
RESTATED AGREEMENT FOR EMERGENCY MEDICAL SERVICES BETWEEN
ATLANTIC AMBULANCE CORP., THE TOWNSHIP OF WARREN, AND WARREN
RESCUE SQUAD**

WHEREAS, Atlantic Ambulance Corp. (“AAC”) is a medical transportation company licensed by the New Jersey Department of Health and Senior Services and certified by the Medicare and Medicaid Programs to provide basic life support transportation services, specialty care transportation services and mobility assistance vehicle services; and

WHEREAS, the Township of Warren recognizes the vital importance of providing efficient and effective emergency medical services to its residents; and

WHEREAS, the Township of Warren desires to ensure the continued provision of high-quality emergency medical services in collaboration with qualified and capable entities; and

WHEREAS, an existing Agreement (the “Original Agreement”) for Emergency Medical Services exists between Atlantic Ambulance Corp. (“AAC”), the Township of Warren, and Warren Rescue Squad (“Rescue Squad”); and

WHEREAS, it has been determined that certain amendments and restatements to the aforementioned Original Agreement are necessary to address evolving operational and organizational needs; and

WHEREAS, AAC, the Township of Warren, and Rescue Squad have mutually negotiated and agreed upon the terms of the Amended and Restated Agreement for Emergency Medical Services;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey, as follows:

1. After further review and final approval by the Township Attorney of the Amended and Restated Agreement for Emergency Medical Services, which approval will be communicated by the Township Attorney to the Township Clerk at a later date in time, the Mayor and Township Clerk are hereby authorized and directed to execute for and on behalf of the Township the Amended and Restated Agreement for Emergency Medical Services as set forth hereinabove.

2. This Resolution shall take effect immediately upon adoption.
