

**TOWNSHIP OF WARREN  
ORDINANCE NO. 10-17**

**AN ORDINANCE AUTHORIZING THE AMOUNT OF \$30,000 AS AN APPROPRIATION FROM THE CAPITAL IMPROVEMENT FUND TO PROVIDE FOR THE PURCHASE OF A 2010 350 4X4 PICKUP TRUCK WITH PLOW**

**BE IT ORDAINED** by the Township Committee of the Township of Warren, in the County of Somerset and State of New Jersey as follows:

**WHEREAS**, the Warren Township Superintendent of Public Works has recommended the purchase of a 2010 350 4x4 Pickup Truck with Plow and related equipment and appurtenances, which will replace a 1994 pickup that has high mileage and body damage; and

**WHEREAS**, the Township Committee has agreed to said recommendation; and

**WHEREAS**, it is necessary that steps be taken to provide for the establishment of the necessary financial authorization in accordance with New Jersey financial procedures to implement this project; and

**WHEREAS**, funds are available in the Capital Improvement Fund Account No. 03-000-3200 to provide for this purchase;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Committee of the Township of Warren, in the County of Somerset, State of New Jersey as follows:

Section 1) The capital equipment improvement herein described below is hereby authorized as a capital improvement to be made by the Township of Warren, County of Somerset, New Jersey and for the said improvement there is hereby authorized the sum of \$30,000.00.

Section 2) The purpose of this appropriation is for the purchase of a 2010 350 4x4 Pickup Truck with Plow and related equipment and appurtenances.

Section 3) There is hereby authorized an appropriation from the Capital Improvement Fund Account No. 03-000-3200 in the amount of \$30,000.00. The Township Chief Financial Officer shall, prior to the effective date of this ordinance, file with the Township Clerk a statement certifying that sufficient funds are available in the Capital Improvement Fund to make the said appropriation. The original certification shall be attached to the original of the ordinance and shall be kept in the files of the Township Clerk.

Section 4) The Capital Budget of the Municipality is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistencies therewith.

Section 5) Any further action regarding this project may be effectuated by resolution of the Township Committee.

Section 6) If any section or provision hereof shall be adjudged invalid, such determination shall not affect any other provisions hereof, which shall remain in full force and effect.

Section 7) This Ordinance shall be effective upon final adoption and publication thereof in accordance with law.
